Notes: The meeting was held virtually in accordance with Covid-19 precautions.

Summary of the school year. What has worked? What went well? What would you change? Discussion led by Dan Hushion.

A parent spoke up about the convenience of the virtually learning. Her child has stayed remote, and it has worked for her. She was satisfied with the transfer to the Schoology platform, which worked better than Google Classroom. She stated that she would change some things about teacher involvement: she feels as those teachers have not been as involved as they have been in previous years. She also stated that the communication from and with the Family Support Resource Center has been consistent. The social media post, the emails are all being noticed, and the community resource night was great.

Tracy shared that the virtual format worked well to get more parent involvement in meetings and others agreed. She thought that virtual learning worked well at the start but was less engaging for the students as time went on.

Danielle spoke on how virtual has been great, however it is becoming boring because its being a steady routine of the same thing.

Annette stated that the lack of consistency of hybrid learning has been a struggle with small children with hybrid because they are used to being at home with their caregivers and, once they come into school, their behavior is different.

A parent would like to see more PBIS (Positive Behavior Interventions and Supports) used by schools, incentives for students to maintain motivation.

Legislative updates:

- Dr. Keen spoke about Maryland bills related to Special Education
 - SB 371/<u>HB 716</u> this bill allows a parent to request an independent educational evaluations at the public expense if the parent disagrees with the educational evaluation of the student that was conducted by the LSS or the parent submits a written request for an educational evaluation to be conducted by the LSS and the LSS doesn't respond within 30 days
 - SB 300/<u>HB 714</u> this bill requires every IEP developed for an eligible student with a disability contain a learning continuity plan to be implemented during emergency conditions.
 - SB 958/ <u>HB 1365</u> This bill allows for nonpublic Special Education Schools to have a 4% state contribution increase which is exclusively for direct classroom positions, related services positions and general support positions.
 - <u>SB 138</u>/ HB 288 This establishes audiology and speech/language pathology interstates compacts, allowing LSSs to hire therapist from other participating states, and <u>SB 139</u>/ HB 540 – establishes an Occupational therapy Interstate Compact.
 - SB 965/ HB 1372, which is the <u>blueprint</u> for Maryland's future revisions/increased funding for programs including: Early Childhood/Family Support (expanding prek & Judy Centers), At-Promise Students, Diverse Teachers & Leaders, College & Career Readiness, Accountability & Governance.

A new Parent's Guide for Navigating Compensatory Education/ Recovery Services. This guide was issued May 11, 2021 and is available from MSDE. This was grounded in law to help parents understand effective strategies before, during, and after the Compensatory Education/ Recovery Services discussion. This <u>interactive tool</u> accompanies the guide to support families. Check it out!

The final update was that MSDE expects all schools in Maryland to be fully open for five days per week, with no hybrid learning, in fall 2021.
